
### The benefits of accreditation

### Accreditation and certification visits

EuroMedi International auditors will visit your facility to see if you have implemented the best practices in the guides. There are three types of visits:

- 1. a *gap analysis* visit to see where your establishment at the beginning of the process (optional)
- 2. a dry run before the final visit (optional)
- 3. the accreditation visit by expert auditors
